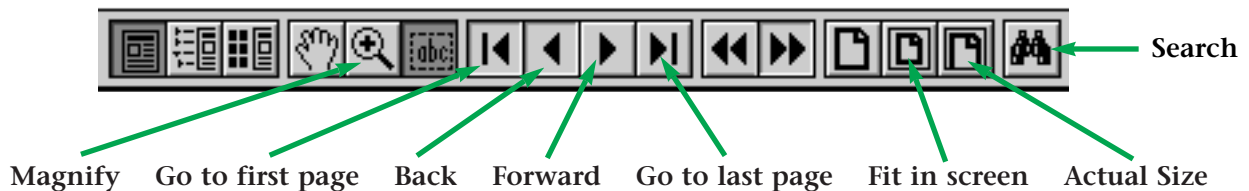

Welcome to the genealogy section dowdgen.com. Currently only the first two generations of Dowds of English descent are presented. More generations will be posted soon.

In *The Descendants of Henry Doude*, Willis Wedworth Dowd made a number of errors and omissions that were reprinted many times and passed along as fact to this day. His scholarship was phenomenal for the time. However, he did not have access to databases and the research tools we have now. In an attempt to set the records straight about our distant ancestors and their family ties, I've assembled what I've learned about them from a number of sources. Whenever I can, I identify those sources so that any researcher may verify, correct, or expand on them. On the following page, a list of definitions are provided for the entire genealogy section.

**Acrobat Reader** enables you to view documents page by page or do a search. If you're looking for Rebecca Doud, for example, select the Binoculars icon in the menu bar. Type in the full name. Select "Find". If there are no results, try again using different spellings of Doud: Dowd, Doude. Be sure to do more than one search. Try "Find Again" to see if there is another Rebecca Doud in a different family line. Try different spellings of the surname, too: Rebekkah, Rebekah.

**Using the Acrobat Reader menu bar:**



To avoid large file sizes that take a long time to download, the generations are presented as separate sections. They are linked to each other but not searchable across generations. The links appear at the beginning and end of each generation.

For example: Jacob Doude, who is not accounted for in Generation three of W.W.'s book but is the son of Ebenezer (#00023) has been designated as 00023a.

Whenever possible, I refer to the primary sources where the information presented can be verified. *Guilford Births, Marriages, Deaths 1645 – 1716 Vol. A* is the reference of choice for that period of time, being a reproduction of the original documents. Many parts of it are extremely difficult to read, however, due to the deterioration of the originals and the quaintness of the script.

Anyone doing a Web search on Henry Doude is likely to find Elizabeth Woolett listed as his wife. It may be that the LDS source for this widely disseminated misinformation is the remarriage record for Henry Doude, Senior.

That record shows:

*Doude, Henry of Woodchurch, husb., widr, about 43, and Elizabeth Woolett, s.p., about 35, whose parents are dead. At S. Georges Cant. 18 Oct. 1626.*

Here Henry is identified as a “widr” (widower), suggesting that he is Henry Doude, Sr. Elizabeth, who was 35 at that time, would have to have been 59 when her son, Thomas, was born twenty-four years later in Guilford in 1650. (Guilford Vital Record: A:124)

It’s more likely That the Woodchurch records showing the 2 May 1635 marriage of Elizabeth Dadson to Henry Doude is the one that is relevant to our genealogy. That record shows:

*Doude, Henry of Tenterden, husb., ba., about 22, whose father consents and Elizabeth Dadson of Maidstone, V., about 22, d. of Ambrose Dadson, s.p. , husb., who also consents .At Langley. John Effeild of Otham, carpenter, bonds. 2 May 1635.*

I share the opinion of Esther Littlefield Woodford-Barnes that Elizabeth Dadson was probably our Henry’s wife. She was of childbearing age from 1635 to 1650. Her date of death, around 1680, would have meant that she was in her early fifties when she died. Elizabeth Woolett would have been 87.

Both marriages are listed in Canterbury Marriage Licenses, Vol. \_\_ p. 294. Tenterden Parish Register is in the Kent Co. Archives.

Copies of some original 7Woodchurch parish records are in my possession.
